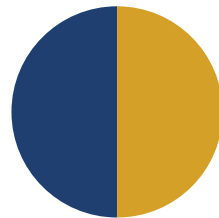

Benchmark Description: The Blended 50 Static vs 50 Flexible Benchmark is comprised of 50% Dow Jones Global Moderate Index and 50% Lipper Alternative Multi Strategy Funds Index, is rebalanced annually, and is a composite of asset allocation strategies representing a "best-fit" benchmark for the portfolio. You cannot invest directly in an index. The benchmark is not intended as direct comparisons to the performance of the portfolio. Instead, it is intended to represent the performance of certain sectors of the overall securities market (e.g. equities, bonds, etc.), so that an investor may compare the effects of material market or economic conditions on the results portrayed.
